Atty. Don H. Culvera inquired if there were prospective bidder/s for the aforesaid Infrastructure Project and there was none. Nonetheless, Atty. Culvera requested Engr. Mark Wilson M. Torres, Member, TWG to explain the requirements, terms and conditions stipulated in the bidding documents, eligibility requirements and the technical and financial components of the said Infrastructure Project.

Engr. Torres clarified and explained the following requirements, terms and conditions stipulated in the Invitation to Bid for the Rehabilitation of Evacuation Center, Brgy. VII, Mercedes, Camarines Norte, to wit:

VII, Mercedes, Camarines Norte (replacement of 394.72m roofing). Completion of works is required for 45CD.
