PROCEEDINGS OF THE MEETING

The meeting was called to order at 2:00 P.M.

Atty. Don H. Culvera, Chairperson of the Bids and Awards Committee presided the meeting. The Secretariat recorded the minutes thereof.

Ms. Nancy U. Hernandez, Member, BAC Secretariat made the roll call and informed the Chairperson that four (4) out of five (5) Members of the Bids and Awards Committee were present, hence, there was a quorum.

Item No. 7. Business of the Day

a. Pre-bid Conference of the following:

a.1 Construction of CNPH Annex (Sta. Elena District Hospital), Sta. Elena, Camarines Norte

Atty. Don H. Culvera inquired if there were prospective bidder/s for the aforesaid Infrastructure Project and Mr. Zaldy O. Porcalla of AKN Construction Corporation and Mr. Jerick F. Peralta of JHR Enterprises signified their intention to bid for the said project. Atty. Culvera requested Engr. Sahlee T. Yanto, Head, TWG to explain the requirements, terms and conditions stipulated in the bidding documents, eligibility requirements and the technical and financial components of the said Infrastructure Project.

Engr. Yanto clarified and explained the following requirements, terms and conditions stipulated in the Invitation to Bid for Construction of CNPH Annex (Sta. Elena District Hospital), Sta. Elena, Camarines Norte, POW #2, viz:

- 1. The Provincial Government of Camarines Norte through the DBP Loan intends to apply the sum of One Hundred Forty Nine Million Nine Hundred Seventy Seven Six Hundred Six Pesos & 88/100 (P149,977,606.88) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of CNPH Annex (Sta. Elena District Hospital), Sta. Elena, Camarines Norte, POW #2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Provincial Government of Camarines Norte now invites for the Construction of 2549.31 sq.m. Hospital Main Building 141.28 sq.m. Motorpool Building 150.91 sq.m. Isolation Building 190.91 sq.m. Dietary Building. Completion of works is required for 450CD. Bidders should have completed a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the Bidding Documents at the address indicated in the ITB from 8:00 a.m. to 5:00 p.m., Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on October 28 November 17, 2020 at the Bids and Awards Committee, 2nd Floor, Provincial Capitol Building, Daet, Camarines Norte and from the website of the Philippine Government Electronic Procurement System (PhilGEPS) upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos (P50,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Provincial Government of Camarines Norte will hold a Pre-bid Conference on November 5, 2020, 2:00 p.m. at Bids and Awards Committee Office, 2nd Floor,

Provincial Capitol Building, Daet, Camarines Norte, which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address indicated in the ITB on or before November 17, 2020, 1:30 p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of acceptable forms and in the amount stated in ITB Clause 15.
- 9. Bid opening shall be on November 17, 2020, 2:00 p.m. at Bids and Awards Committee Office, 2nd Floor, Provincial Capitol Building, Daet, Camarines Norte. Bids will be opened in the presence of the bidder's representatives who choose to attend the activity.
- 10. The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35 and 41 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.

a.2 Construction of Farm to Market Road, Brgy. Mabilo I to Mabilo II, Labo, Camarines Norte

Atty. Don H. Culvera inquired if there were prospective bidder/s for the aforesaid Infrastructure Project and there was none. Nonetheless, Atty. Culvera requested Engr. Sahlee T. Yanto, Head, TWG to explain the requirements, terms and conditions stipulated in the bidding documents, eligibility requirements and the technical and financial components of the said Infrastructure Project.

Engr. Yanto clarified and explained the following requirements, terms and conditions stipulated in the Invitation to Bid for the Construction of Farm to Market Road, Brgy. Mabilo I to Mabilo II, Labo, Camarines Norte, POW #47, viz:
