 The Provincial Government of Camarines Norte, through the 20% DF - AB 2023 intends to apply the sum of Three Million Four Hundred Ninety-Six Thousand Eight Hundred Fifty-Two Pesos (P3,496,852.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Covered Court with Stage, Brgy. Bakal, Paracale, Camarines Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
The Provincial Government of Camarines Norte now invites bids for the Construction of 15m x 20m Covered Court with Stage, Concrete Pavement (16.00m x 12.70m x 0.10m thk.), One End Side Tinning and Framing. Completion of the Works is required 150 CD. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
