## **Description**

Invitation to Bid for the Expansion of Provincial Road, Brgy. Sta. Cruz, Labo, Camarines Norte

The Provincial Government of Camarines Norte, through the SB No. 2 PEO Capital Outlay 2023 intends to apply the sum of Four Million Nine Hundred Eighty-Seven Thousand Eight Hundred Fifty-One Pesos and Twenty-Eight Centavos (P4,987,851.28) being the Approved Budget for the Contract (ABC) to payments under the contract for the Expansion of Provincial Road, Brgy. Sta. Cruz, Labo, Camarines Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Provincial Government of Camarines Norte now invites bids for the Concreting of  $942.10LM \times 1.50m \times 0.20m$ ,  $21.50LM \times 0.50m \times 0.20m$  and  $20.40LM \times 1.00m \times 0.20m$  road (road widening) with stone masonry (as per plan).
