The Provincial Government of Camarines Norte, through the SB No. 1 20% Development Fund intends to apply the sum of One Million Nine Hundred Ninety-Six Thousand Nine Hundred Fifty-Two Pesos and Eighty-Eight Centavos (P1,996,952.88) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Road, Brgy.
