Description

Invitation to Bid for the Improvement/Rehabilitation of Tomas Mancenido Sports Complex, Brgy. Poblacion, Talisay, Camarines Norte

- 1. The Provincial Government of Camarines Norte, through the SB No. 2 PEO Capital Outlay 2023 intends to apply the sum of Four Million Nine Hundred Ninety-Nine Thousand Six Hundred Seventy-One Pesos and Ninety-Six Centavos (P4,999,671.96) being the Approved Budget for the Contract (ABC) to payments under the contract for the Improvement/Rehabilitation of Tomas Mancenido Sports Complex, Brgy. Poblacion, Talisay, Camarines Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Provincial Government of Camarines Norte now invites bids for the Rehabilitation/Improvement of $21.15 \,\mathrm{m}\,\mathrm{x}$ 30m Existing Covered Court. Completion of the Works is required 120 CD. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- 4. Bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the Bidding Documents at the address given below from 8:00a.m. to 5:00p.m., Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders December 4 December 26, 2023 at the Provincial Capitol Building, Daet, Camarines Norte and from the website of the Philippine Government Electronic Procurement System (PhilGEPS) upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on December 12, 2023, 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte, which

shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before December 26, 2023 at 1:30p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
- 9. Bid opening shall be on December 26, 2023, 2:00 p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35 and 41 of RA 9184 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.
