Description

Invitation to Bid for PR No. 23041081 – Supply and Delivery of Drugs and Medicines (Acetylcysteine 100mg sachet & 62 others)

1. The Provincial Government of Camarines Norte, through the General Fund CY 2023 intends to apply the sum of Four Million Seven Hundred Fifty Thousand Pesos (P4,750,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 23041081 – Supply and Delivery of Drugs and Medicines (Acetylcysteine 100mg sachet & 62 others). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Camarines Norte now invites bids for the Supply and Delivery of Drugs and Medicines (Acetylcysteine 100mg sachet & 62 others).

Delivery of the Goods is required within 30 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of
