#### Description

Invitation to Bid for PR No. 23092365 – Supply and Delivery of Materials (Portland Cement & 33 others) for the Installation of Solar Street Lights at Brgy. Tabugon, Sta. Elena, Camarines Norte

1. The Provincial Government of Camarines Norte, through the PEO - General Fund CY 2023 intends to apply the sum of One Million Eight Hundred Four Thousand One Hundred Fifty-Six Pesos and Twenty Centavos (P1,804,156.20) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 23092365 – Supply and Delivery of Materials (Portland Cement & 33 others) for the Installation of Solar Street Lights at Brgy. Tabugon, Sta. Elena, Camarines Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Camarines Norte now invites bids for the Supply and Delivery of Materials (Portland Cement & 33 others) for the Installation of Solar Street Lights at Brgy. Tabugon, Sta. Elena, Camarines Norte.

Delivery of the Goods is required within 60 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Bidders may obtain further information from the Provincial Government of Camarines Norte and inspect the

Bidding Documents at the address given below from 8:00a.m. to 5:00p.m., Monday to Friday.

5. A complete set of Bidding Documents may be acquired by interested bidders on November 10 – December 5, 2023 at the Provincial Capitol Building, Daet, Camarines Norte and from the website of the Philippine Government Electronic Procurement System (PhilGEPS) upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on November 21, 2023, 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before December 5, 2023 at 1:30p.m. Late bids shall not be accepted.

8. All bids must be accompanied by a bid Ssecurity in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on December 5, 2023 at 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35 and 41 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.
