## Description

The Provincial Government of Camarines Norte, through the GO USSAP General Fund CY 2024 intends to apply the sum of Nine Million One Hundred Ninety-Five Thousand Pesos (P9,195,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 24020440 Supply and Delivery of Drugs and Medicines (Ascorbic Acid 100mg/ml drops 15ml & 60 others). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The Provincial Government of Camarines Norte will hold a Pre-Bid Conference on March 5, 2024, 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before March 19, 2024 at 1:30p.m. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on March 19, 2024 at 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
