Description

Invitation to Bid for PR No. 24030865 - Supply and Delivery of Laboratory Supplies (HIV Rgt ½ 3.0, 30's & 22 others)

- 1. The Provincial Government of Camarines Norte, through the CNPH General Fund AB2024 intends to apply the sum of Seven Hundred Ninety-Four Thousand Six Hundred Fifty Pesos (P794,650.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR No. 24030865 Supply and Delivery of Laboratory Supplies (HIV Rgt $\frac{1}{2}$ 3.0, 30's & 22 others). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Provincial Government of Camarines Norte now invites bids for the Supply and Delivery of Laboratory Supplies (HIV Rqt ½ 3.0, 30's & 22 others).

Delivery of the Goods is required within 30 calendar days. Bidders should have completed, within 5 years from the date of submission and receipt of bids, a contract similar to the Project. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. Bids must be duly received by the BAC Secretariat through manual submission at the address below on or before April 11, 2024 at 1:30p.m. Late bids shall not be accepted.
- 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 8. Bid opening shall be on April 11, 2024 at 2:00p.m. at the new BAC Conference Office, at the back of Agro-Sports Center, J. Lukban Street, Daet, Camarines Norte. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Provincial Government of Camarines Norte reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the revised IRR of RA 9184 without thereby incurring any liability to the affected bidder or bidders.
