- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

Iberica, Labo, Camarines Norte in accordance with his/her/its
- The Provincial Government of Camarines Norte agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
