KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made this 11th day of April, 2023 between the Provincial Government of Camarines Norte, Provincial Capitol, Daet, Camarines Norte (hereinafter called "the Entity") and MODR Construction and Supply, 4th Street, Parkview Village, San Felipe, Naga City, Camarines Sur (hereinafter called "the Contractor").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- Notice of Award of Contract; and the Bidder's conforme thereto;
 and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs and of Annex G of the revised IRR of RA 9184. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after



the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of Two Million Nine Hundred Ninety 3. Thousand Fifty and 30/100 pesos only (P 2.990,050.30) or such other sums as may be ascertained, MDQR Construction and Supply agrees to complete the CONSTRUCTION OF VILLA BELEN TO DEL PILAR CROSSING ROAD, Brgy. Villa Belen, Capalonga, Camarines Norte in accordance with his/her/its Bid.
- The Provincial Government of Camarines Norte agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
