THIS AGREEMENT made this ______ day of ______, 2023 between PROVINCIAL GOVERNMENT OF CAMARINES NORTE, Provincial Capitol Daet, Camarines Norte of the Philippines (hereinafter called "the Entity") of the one part and HONEYBLEST TRADING of Block 65 Lot 8A Pound St., United North Fairview, Quezon City, Metro Manila, NCR, Philippines (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation:

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs.
- In consideration for the sum of One Million One Hundred Ninety Eight Thousand Eight Hundred Pesos only (P1,198,800.00) (or such other sums as may be ascertained, HONEYBLEST TRADING agrees to deliver One (1) unit Transport Vehicle in accordance with his/her/its Bid.
- The PROVINCIAL GOVERNMENT OF CAMARINES NORTE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
